Cart shed fees are \$325.00 per year and \$425.00 in the new cart shed. Due by March 15<sup>th</sup>.

Golf cart trail fees are \$225.00 per year if your cart is not, kept onsite. Due by March 15<sup>th</sup>.

\*\*\* All Social members may only golf 2 times per year including 2-ball, tournaments, special events etc.

Full green fees will apply in addition to registration fees for events.

Stock Fee of \$1000.00 is required to become full voting member and may be paid in four annual installments of \$250.00 each year. Installation payments are non-refundable at the time of resignation. No Stock Fees or Capital Improvement Fund charge to Student Memberships.

**All Members** are required to meet a food minimum on a monthly or yearly basis. The only exception: Students, 1<sup>st</sup> Year Members and Members outside the 12-mile radius. Yearly Food Minimum rate is 12 times the monthly rate paid in full at the beginning of each year. Monthly basis are as follows:

Family Member: \$60.00/mo.-\$720/yr. Single Member: \$40.00/mo.-\$480.00yr

1<sup>st</sup> Yr Member: \$0.00 2nd Yr Member: \$30.00/mo.-\$360.00/yr 3rd Yr Member: Full Rates Apply

### **Capital Improvement Fund**

All members, except Student and Lifetime Memberships, will be charged \$15 (plus tax) per month toward the fund.
